1. Call to Order

The Council Meeting was called to order at 6:35pm.

2. Approval of Previous Minutes

The previous Council Minutes of November 8, 2022 were approved as circulated.

3. Approval of Agenda

5. First Reading:

a. Foster and Bentley - Development Agreement

IT WAS MOVED and seconded

THAT

Town Council approves First Reading of the development agreement between the Town of Berwick and John Malcolm Foster, agreeing to the proposed change to the draft development agreement, and forward to a public hearing.

b. Apple Valley Foods - Development Agreement

IT WAS MOVED and seconded

THAT

Town Council approve First Reading of the development agreement between the Town of Berwick and Apple Valley Foods for 245 Commercial Street (PID 55238844) to allow a nine-room board house with a maximum occupancy of 12 people and forwarded to a public hearing.

6. Second Reading:

a. Liberty Lodge - Rezoning 124 Orchard Street

Council pass second reading for the proposed rezoning of 124 Orchard Street from R1 to R2.

7. New Business

a. RFD: Boundary Review Report

Much discussion ensued with regards to review of Council's size. Council discussed the survey's low response rate and it not being statistically relavant. Although, the qualitative information that was received was valuable. The survey should not be the deciding factor for determining the number of elected officials for Berwick.

Council discussed the number of Committees of Council being a potential barrier if there were less Councillors, deterring individuals who have full-time

employement from participating. As well, per the comments from the public, Council agreed that remaining at six Councillors plus a Mayor, would ensure space for diversity at the table.

Other reasons for status quo, is there needs to be a critical mass of Council to deal with sickness/absences and the financial impact/savings of a councillor was not significant.

Council confirm the number of Councillors elected for the Town of Berwick remain status quo (Mayor and 6 Councillors at large).

b.Memo: Holiday Policy Discussion

Discussion ensued regarding staff receiving three paid days off between Christmas and New Years. The Town's Holiday Policy was amended in 2005 to include the three days between Christmas and New Years. The Policy will be reviewed per the Compensation Review.

THAT

Council approve the three days between Christmas and New Years be paid as holidays per the Holiday Policy.

c.Temporary Leave of Council for Councilor Reeves

On October 11, 2022, Councillor Reeves notified Council that he was not currently living within Town boundaries, but wishes to find a place in Town. Per section 17(6) of the Municipal Government Act, Council can approve one period of not more than six months in a term, where a member of Council may be ordinarily resident outside of the municipality.

If Councillor Reeves has not made arrangements to move back to Town by April 11, 2023 a special election will need to take place.

THAT

Council approve one period of six months, starting October 11, 2022, where Councillor Reeves may be ordinarily resident outside the Town until April 11, 2023.
